#### **CARA MEMBAYAR WANG KE MAHKAMAH MENURUT SEKSYEN 29 ACT PENGAMBILAN TAHUN 1960**

Pekeliling Penasihat Tanah dan Galian No. 5/1957 memberi nasihat dan panduan kepada Pegawai-pegawai Tanah akan kaedah membayar ke Mahkamah wang gantirugi tanah yang diambil oleh Kerajaan dengan menggunakan kuatkuasa di bawah Undang-undang Pengambilan Tanah. 2. 3. Lampiran ‘C’ adalah borang tambahan iaitu boring yang mustahak digunakan apabila hendak mengeluarkan wang yang ada dalam simpanan Mahkamah itu.
