PELAKSANAAN SISTEM METRIK:PINDAAN KEPADA KELANTAN LAND RULES 1966

Tujuan Pekeliling ini ialah untuk memaklumkan kepada semua Pemungut Hasil Tanah iaitu mulai 1.1.1982 Kelantan Land Rules 1966, Mining Enactment 1939 dan The Mining Rules 1940 telah dipinda. Pindaan-pindaan ini timbang dilaksanakan dengan sepenuhnya.

2. Bersama ini dikembarkan satu salinan pindaan kepada Kelantan Land Rules, 1966 yang telah dilulus untuk digunakan mulai 1.1.1982. Pindaan kepada Mining Enactment 1939 dan The Mining Rules 1940 akan dihantar melalui Pekeliling yang berasingan. Sila ambil perhatian bahawa pindaan ini tidak menjejaskan unit-unit dan kadar-kadar bayaran bagi tanah-tanah yang telah diberimilik atau dilupuskan.
